### **H\*3121 (Rat #0630, Act #0518 of 1990) General Bill, By J.T. McElveen, R.S. Corning, J.H. Hodges and T.E. Huff**

A Bill to amend Section 20-3-130, Code of Laws of South Carolina, 1976, relating to allowances in divorce judgments, so as to establish factors for the family court to consider in awarding alimony or maintenance and in ordering payment of costs and attorney fees and to delete the provision which prohibits alimony in cases of adultery.
