**S\*0315 (Rat #0483, Act #0439 of 1988) General Bill, By Drummond**

***Similar (H 2280)***

A Bill to reauthorize the South Carolina State Board of Dentistry for six years; to amend Section 40-15-20, Code of Laws of South Carolina, 1976, relating to the membership of the Board, so as to authorize the dental hygienist member to vote on disciplinary matters for dentists; to amend Section 40-15-80, relating to the definition of "dental hygiene", so as to provide the conditions under which a person is considered to be practicing dental hygiene, and to provide authorizations and limitations on the type of treatment which may be provided by licensed dental hygienists.-amended title
