A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 43-35-13 so as to provide that no vulnerable adult may be considered abused or neglected for the sole reason that the vulnerable adult is being furnished nonmedical remedial treatment by spiritual means.
