A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 61-2-175 SO AS TO CREATE A MISDEMEANOR OFFENSE FOR SHIPPING BEER, WINE, OR ALCOHOLIC LIQUORS TO A RESIDENT OF THIS STATE WHO DOES NOT HOLD A LICENSE OR CERTIFICATE OF REGISTRATION AND TO ESTABLISH CRIMINAL AND ADMINISTRATIVE PENALTIES; TO ADD SECTION 61-6-2230 SO AS TO PROHIBIT AN ALCOHOLIC BEVERAGE LICENSEE FROM CONDUCTING DRINKING CONTESTS AND DRINKING GAMES; AND TO AMEND SECTION 61-4-580, RELATING TO PROHIBITED ACTS BY HOLDERS OF BEER AND WINE PERMITS, SO AS TO INCLUDE CONDUCTING DRINKING CONTESTS AND DRINKING GAMES AS A PROHIBITED ACT.-AMENDED TITLE
