**Summary:** War Roster of military who served in certain wars

AN ACT TO AMEND CHAPTER 11, TITLE 25, CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 25-11-90 SO AS TO PROVIDE FOR A ROSTER PREPARED AND DISTRIBUTED BY THE DIVISION OF VETERANS AFFAIRS TO INCLUDE THE NAME AND PRINCIPAL ITEMS OF RECORD OF SPECIFIED PERSONS WHO SERVED ON ACTIVE DUTY DURING CERTAIN OPERATIONS OR CONFLICTS AND AN ORDER OF BATTLE INCLUDING SOUTH CAROLINA UNITS PARTICIPATING IN THE OPERATIONS OR CONFLICTS; AND TO REPEAL SECTION 73, PART II OF ACT 164 OF 1993 RELATING TO PUBLICATION AND DISTRIBUTION OF OTHER MILITARY ROSTERS. - ratified title
