A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 8-11-180 so as to authorize a state employee who is a certified disaster service volunteer for the American Red Cross not more than fifteen days paid leave in a year to participate in specialized disaster relief services of the American Red Cross and to make such leave available only with the approval of the employee's employer.
