A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 34-3-110 so as to provide for the crimes of defrauding a federally chartered or insured financial institution and obtaining property of the institution fraudulently, define terms, and provide penalties; and to amend Section 16-1-10, as amended, so as to include the offense provided for in this
