A Bill to provide that any kennel or dog owner may register his dog or kennel with the South Carolina Wildlife and Marine Resources Department and have the registration number or letter tattooed in the ear of any registered dog, to require information to be made available to animal control agencies and individuals, to provide for the payment of the costs involved in administering the program, to provide for the notification of the owner by animal control officers before destroying the animal, to provide for the promulgation of regulations, and to provide penalties.-amended title
