**H\*3535 (Rat #0406, Act #0379 of 1988) General Bill, By Boan and J.W. McLeod**

A Bill to amend Section 38-51-10, Code of Laws of South Carolina, 1976, relating to the definition of administrator of insurance benefits plans, so as to exempt the South Carolina Life and Accident and Health Insurance Guaranty Association and any person who adjusts or settles claims as its employee or agent; and to amend Section 38-29-170, relating to immunity from liability for any action taken under the provisions of Chapter 29 of Title 38, so as to eliminate the immunity from liability the South Carolina Life and Accident and Health Insurance Guaranty Association.-amended title
