A Bill to amend the Code of Laws of South Carolina, 1976, by adding Sections 5-3-15 and 55-11-185 so as to provide that the real property owned by an airport district composed of more than one county may not be annexed by a municipality without prior written approval of the governing body of the district, and provide that the real property owned by the Greenville-Spartanburg Airport District may not be annexed by a municipality without prior approval of the Greenville-Spartanburg Airport Commission; to amend the 1976 Code by adding Section 55-11-220 so as to provide that airport district property is not a barrier to the contiguity requirements for purposes of annexation.-amended title
