**H\*3618 (Rat #0525, Act #0446 of 1980) General Bill, By B.H. Harwell, R.L. Altman, A.H. Buchan, C.D. Chamblee, D.N. Holt, Koon, Matthews, J.D. McInnis, McKay, D.E. McTeer, F.T. Moore, K.W. Shelley, J.J. Snow, M.H. Westbrook, D.E. Winstead and J.T. Wood**

A Bill to amend Chapter 9 of Title 50, Code of Laws of South Carolina, 1976, relating to hunting, fishing and trapping licenses, by adding Section 50-9-135, so as to require nonresident big-game hunters to purchase a big-game permit; to amend Section 50-9-190, relating to carrying and showing hunting licenses while hunting, so as to require game management and big-game permits to be carried on the person of the licensee while hunting; to amend Section 50-9-250, relating to penalties for certain violations by nonresident hunters, so as to increase the penalties and to exempt licensed shooting preserves from the provisions of this Act.-at
