**H\*3713 (Rat #0742, Act #0634 of 1988) General Bill, By H.E. Pearce, K.E. Bailey, L.E. Bennett, E.D. Foxworth, F. Gilbert, T.T. Mappus, R.N. McLellan, L. Phillips, J.I. Rogers, Sharpe, Sheheen, C.L. Sturkie, C.C. Wells and J.M. White**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Sections 48-39-270 through 48-39-360 so as to provide for beach protection through a forty-year program to restore the beach/dune system to its natural dynamic equilibrium; to amend Section 48-39-10, relating to definitions pertaining to coastal tidelands and wetlands, so as to revise the definition of "critical area"; and to amend Section 48-39-130, relating to permits to utilize critical areas, so as to revise the exception for emergency repairs without a permit.
