A Bill to amend Section 14-21-620, Code of Laws of South Carolina, 1976, relating to disposition of juvenile cases by the family courts, so as to permit the court to order restitution or participation in supervised work or community service under the supervision of the Department of Placement and Aftercare and local community agencies as a condition of probation in the case of any child who is adjudicated as delinquent for a violation of any state law or municipal or county ordinance.-at
