A BILL TO AMEND SECTION 11-27-110, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO LEASE PURCHASE OR FINANCING AGREEMENTS BEING SUBJECT TO APPLICABLE CONSTITUTIONAL DEBT LIMITATIONS, SO AS TO CONFORM THE TREATMENT OF A LEASE PURCHASE AGREEMENT FOR ENERGY EFFICIENCY PRODUCTS AND A GUARANTEED ENERGY SAVINGS CONTRACT IN THE CALCULATION OF THE DEBT LIMIT TO THE PROVISIONS OF THE SECTION SPECIFICALLY EXCLUDING THEM FROM THOSE TYPES OF AGREEMENTS SUBJECT TO THE DEBT LIMIT, TO ADD CERTAIN LOAN AGREEMENTS FOR CONSERVATION MEASURES TO THESE EXCLUSIONS AND PROVIDE THAT THESE AGREEMENTS OR CONTRACTS DO NOT CONSTITUTE ANY AGREEMENT TO PROVIDE RETAIL SALES OF ENERGY, AND TO MAKE TECHNICAL REFERENCE CHANGES; AND TO AMEND SECTIONS 48-52-650 AND 48-52-660, RELATING TO STATE GOVERNMENT ENERGY CONSERVATION, SO AS TO ALLOW POLITICAL SUBDIVISIONS OF THE STATE TO PARTICIPATE IN THE REVOLVING LOAN FUND OF THE STATE ENERGY OFFICE AND AUTHORIZE POLITICAL SUBDIVISIONS TO ENTER INTO LEASE PURCHASE AGREEMENTS FOR MORE THAN ONE YEAR WITH VENDORS OF ENERGY EFFICIENCY PRODUCTS AND UTILITY COMPANIES.-AMENDED TITLE
