A Bill to amend Section 10-1-30, Code of Laws of South Carolina, 1976, relating to the use of the State House steps, grounds, and the Capitol Mall, so as to delete the reference to the Capitol Mall, include the State House lobbies and other public buildings and grounds, and provide for the Budget and Control Board to promulgate regulations, and revise the requirements authorizing the use of the areas including the Gressette and Blatt Buildings.-amended title
