**H\*3957 (Rat #0325, Act #0262 of 2002) General Bill, By J.E. Smith and Allison**

**Summary:** Maternal, Infant, and Child Health Act and Council, repealed

A BILL TO REPEAL ARTICLE 21, CHAPTER 7, TITLE 20, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE STATE COUNCIL ON MATERNAL, INFANT, AND CHILD HEALTH ACT, THE CREATION OF THE COUNCIL AND PROVIDING FOR ITS POWERS AND DUTIES.
