A Bill to amend Section 56-3-670, as amended, Code of Laws of South Carolina, 1976, relating to fees for farm truck licenses, so as to provide that the fees apply to the gross vehicle weight, to revise the fees, and to provide that this provision does not exempt farm vehicles from certain gross weight-axle requirements.-amended title
