AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 23-3-75 SO AS TO PROVIDE THAT AN OFFICER OF THE COURT WHO IS EMPLOYED BY THE SOUTH CAROLINA LAW ENFORCEMENT DIVISION MAY ISSUE AN ADMINISTRATIVE SUBPOENA TO A FINANCIAL INSTITUTION, PUBLIC OR PRIVATE UTILITY, OR COMMUNICATIONS PROVIDER FOR THE PRODUCTION OF RECORDS DURING THE INVESTIGATION OF CERTAIN CRIMINAL CASES THAT INVOLVE FINANCIAL CRIMES. - ratified title
