### **H\*4332 (Rat #0340, Act #0321 of 1994) General Bill, By Sheheen, I.K. Rudnick and Stuart**

A Bill to amend Section 7-19-40, Code of Laws of South Carolina, 1976, relating to Congressional districts, so as to reapportion and further provide for the composition of the districts in accordance with the United States Census of 1990, to further provide for Congressional district representatives on boards, committees, and commissions, to provide for the manner in which certain vacancies must be filled, and to provide that the Speaker of the House and the President Pro Tempore of the Senate are jointly designated as the submitting authority to make the required submission of the Congressional reapportionment plan to the United States Department of Justice under the Voting Rights Act.-amended title
