**H\*4358 (Rat #0310, Act #0287 of 1998) General Bill, By Loftis, J. Brown, Cato, Leach, Robinson, Stille and Vaughn**

A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 40-33-770 SO AS TO AUTHORIZE LICENSED PRACTICAL NURSES TO PROVIDE CERTAIN SERVICES IN RESIDENTIAL SETTINGS, PUBLIC SCHOOLS, AND DEPARTMENT OF JUVENILE JUSTICE AND DEPARTMENT OF CORRECTIONS FACILITIES AND INSTITUTIONS WITHOUT THE ON-SITE SUPERVISION OF A NURSE, DOCTOR, OR DENTIST IF CERTAIN PROCEDURES ARE FOLLOWED.-AMENDED TITLE
