### **S\*0445 (Rat #0077, Act #0046 of 1987) General Bill, By Land**

A Bill to amend Section 50-9-470, as amended, Code of Laws of South Carolina, 1976, relating to the temporary nonresident fishing license, so as to provide that the license authorizes the licensee to fish in any of the waters of this State for a period of seven, rather than ten, specified consecutive days, and to decrease the fee for the license from twenty dollars and fifty cents to eleven dollars.-amended title
