**H\*4501 (Rat #0483, Act #0395 of 1996) General Bill, By Fleming, G.A. Brown, Cato, Clyburn, L.L. Elliott, Littlejohn, Mason, Sandifer, Seithel, R. Smith, E.C. Stoddard, Vaughn, Whipper and L.S. Whipper**

A Bill to amend Section 12-56-20, Code of Laws of South Carolina, 1976, relating to definitions for purposes of the Setoff Debt Collection Act, so as to exclude from the definition of "delinquent debt" sums owed a county hospital when the hospital and the debtor have entered into a written payment agreement and the debtor is current in meeting the obligations of the agreement and to delete the requirement that a delinquent debt be a "liquidated" sum.-amended title
