**H\*4585 (Rat #0428, Act #0351 of 1996) General Bill, By Klauber**

***Similar (S 1207)***

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 38-71-275 so as to provide that no insurance policy which provides coverage for drugs shall exclude coverage of any such drug used for the treatment of cancer on the grounds that the drug has not been approved by the federal Food and Drug Administration for the treatment of the specific type of cancer for which the drug has been prescribed, and to provide for related matters.-amended title
