**H\*4628 (Rat #0457, Act #0400 of 1994) General Bill, By Kirsh, Bailey, Boan, J. Brown, B.H. Harwell and D.C. Waldrop  
Similar (S 1123)**

A Bill to amend Section 40-67-30, Code of Laws of South Carolina, 1976, relating to creation of the Board of Examiners in Speech Pathology and Audiology, so as to revise the name of the Board; to amend Section 40-67-80, relating to membership on the Board, so as to provide for two speech-language pathologists on the Board rather than two speech pathologists, to provide that nomination for Board appointment must be made only for the speech-language pathologist and audiologist positions, and to provide that appointments must be with the advice and consent of the Senate; and to reauthorize the State Board of Examiners in Speech-Language Pathology and Audiology for six years.-amended title
