**H\*4629 (Rat #0458, Act #0401 of 1994) General Bill, By Kirsh, Bailey, Boan, J. Brown, B.H. Harwell and D.C. Waldrop  
Similar (S 1115)**

A Bill to amend Section 40-36-60, Code of Laws of South Carolina, 1976, relating to the creation of the Board of Occupational Therapy, so as to require that the Governor's appointments to the Board must be with the advice and consent of the Senate; to amend Section 40-36-120, as amended, relating to licensing requirements for occupational therapy, so as to revise by whom an educational program must be accredited; to amend Section 40-36-180, relating to fees, so as to include verification, rosters, and mail list fees among those fees that the Board may prescribe in regulation; and to reauthorize the South Carolina Board of Occupational Therapy for six years.-amended title
