## S\*0047 (Rat #0111, Act #0094 of 2005) General Bill, By Cromer, Elliott, Fair, Ford and Ritchie

Summary: Criminal sexual conduct penalties

AN ACT TO AMEND SECTION 16-3-655, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO CRIMINAL SEXUAL CONDUCT WITH MINORS, SO AS TO PROVIDE THAT A CONVICTION OF CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE WITH CERTAIN MINORS CARRIES A MINIMUM TERM OF IMPRISONMENT OF TEN YEARS, NO PART OF WHICH MAY BE SUSPENDED OR PROBATION GRANTED, AND TO ADD THAT A PERSON IS GUILTY OF CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE IF THE PERSON ENGAGES IN SEXUAL BATTERY WITH A VICTIM WHO IS LESS THAN SIXTEEN YEARS OF AGE AND THE PERSON HAS A PREVIOUS CONVICTION FOR WHICH HE IS REQUIRED TO BE REGISTERED ON THE SEX OFFENDER REGISTRY; BY ADDING SECTION 23-3-465 SO AS TO PROVIDE THAT A PERSON REQUIRED TO BE REGISTERED ON THE SEX OFFENDER REGISTRY IS PROHIBITED FROM LIVING IN CAMPUS STUDENT HOUSING AT A PUBLIC INSTITUTION OF HIGHER LEARNING IN THIS STATE. - ratified title
