A Bill to amend Chapter 55, Title 44, Code of Laws of South Carolina, 1976, relating to water, sewage, and waste disposal, by adding Article 23 so as to provide for the regulation of public swimming pools by the Department of Health and Environmental Control by enacting the State Recreational Waters Act.-amended title
