A Bill to amend the Code of Laws of South Carolina, 1976, by adding Chapter 32 to Title 59 so as to provide for the establishment of a Comprehensive Health Education Program in elementary and secondary schools through appropriate program development, adequate teacher training, required hours of health instruction, an exemption for student participation, an exception for private schools to the application of the Chapter, and penalties; and to provide for the continuation of existing health education programs and reimbursement of tuition.-amended title
