### **S\*0553 (Rat #0253, Act #0180 of 1987) General Bill, By Senate Judiciary**

#### ***Similar (S 0163)***

A Bill to amend Article 3 of Chapter 13 of Title 7, Code of Laws of South Carolina, 1976, relating to ballots for general and special elections, by adding Section 7-13-325 so as to provide that the name of any candidate authorized to appear on any ballot in any general, special, or primary election for any office may be the candidate's given name, a derivative of his given name, or a nickname, to provide for a procedure for the use of a derivative name or a nickname on the ballot, and to authorize the State Election Commission to promulgate regulations
