### **S\*0557 (Rat #0118, Act #0098 of 2005) General Bill, By Richardson**

**Summary:** Workers' compensation benefits of prisoners

AN ACT TO AMEND SECTION 42-1-500, AS AMENDED, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO WORKERS' COMPENSATION BENEFITS OF PRISONERS IN THE CUSTODY OF THE COUNTY, SO AS TO AUTHORIZE A MUNICIPALITY TO COVER PRISONERS IN CUSTODY OF A MUNICIPALITY AND TO PROVIDE COVERAGE FOR CERTAIN PRISONERS WHEN THE COUNTY OR MUNICIPALITY ELECTS TO COVER ITS PRISONERS; AND TO AMEND SECTION 42-7-65, AS AMENDED, RELATING TO THE AVERAGE WEEKLY WAGE DESIGNATED FOR CERTAIN CATEGORIES OF EMPLOYEES, SO AS TO ADD MUNICIPAL PRISONERS. - ratified title
