### **S\*0634 (Rat #0398, Act #0305 of 2002) General Bill, By Wilson and Ford**

**Summary:** Selective Service System registration, Motor Vehicle Division to provide

A BILL TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING SECTION 23-6-305 SO AS TO PROVIDE THAT UPON RECEIVING PROPER AUTHORITY FROM THE UNITED STATES GOVERNMENT, THE MOTOR VEHICLES DIVISION OF THE DEPARTMENT OF PUBLIC SAFETY SHALL PROVIDE SELECTIVE SERVICE REGISTRATION FOR CERTAIN INDIVIDUALS AT THE TIME IT ISSUES, RENEWS, OR PROVIDES A DUPLICATE COPY OF A DRIVER'S LICENSE OR IDENTIFICATION CARD, AND TO PROVIDE THAT THE MOTOR VEHICLES DIVISION MUST INCLUDE CERTAIN INFORMATION IN AN APPLICATION FOR A DRIVER'S LICENSE OR IDENTIFICATION CARD THAT INFORMS THE APPLICANT THAT SUBMISSION OF THE APPLICATION SERVES AS CONSENT TO BE REGISTERED WITH THE SELECTIVE SERVICE UNDER CERTAIN CIRCUMSTANCES.-amended title
