### **S\*0700 (Rat #0200, Act #0170 of 1993) General Bill, By Land**

#### **Similar (H 3636)**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 40-57-155 so as to require continuing education as a condition of license renewal of a resident or nonresident real estate broker or salesman, to provide for the administration of the continuing education program, and to authorize the Real Estate Commissioner to promulgate regulations to implement the program; and to amend Section 40-57-160, relating to issuance of licenses, so as to require licenses to be renewed at any time instead of a June thirtieth expiration.-amended title
