A Bill to amend the Code of Laws of South Carolina, 1976, by adding Chapter 47 to Title 27 so as to provide for the South Carolina Manufactured Home Park Tenancy Act by setting forth purposes, scope, jurisdiction, definitions, interpretation of principles, notice, rental agreements, obligations of owners and residents, grounds for eviction, and notification of sale of park, and rezoning.-amended title
