Summary: Notice and Opportunity to Cure Non-Residential Construction Defects Acts

AN ACT TO AMEND THE CODE OF LAWS OF SOUTH CAROLINA, 1976, BY ADDING ARTICLE 3 TO CHAPTER 11, TITLE 40 SO AS TO DEFINE THE TERMS "ACTION", "CLAIMANT", "CONSTRUCTION DEFECT", "CONTRACTOR", "DESIGN PROFESSIONAL", "NONRESIDENTIAL PROPERTY", "SERVE" OR "SERVICE", "SUBCONTRACTOR", AND "SUPPLIER" AND TO PROVIDE PROCEDURES FOR THE RIGHT TO CURE NONRESIDENTIAL CONSTRUCTION DEFECTS BEFORE A CIVIL ACTION OR OTHER REMEDY PROVIDED BY LAW OR CONTRACT MAY BE INSTITUTED OR CONTINUED. - ratified title
