AN ACT TO AMEND THE SOUTH CAROLINA CODE OF LAWS BY AMENDING SECTION 63-11-1930, RELATING TO THE STATE CHILD FATALITY ADVISORY COMMITTEE, SO AS TO ADD THE EXECUTIVE DIRECTOR OF THE SOUTH CAROLINA COMMISSION FOR COMMUNITY ADVANCEMENT AND ENGAGEMENT AS A MEMBER OF THE COMMITTEE, TO ESTABLISH CERTAIN RESTRICTIONS ON SERVING IN A HOLDOVER CAPACITY, AND FOR OTHER PURPOSES. - RATIFIED TITLE
