### **S\*0916 (Rat #0227, Act #0268 of 2016) General Bill, By Malloy, Fair and M.B. Matthews**

**Summary:** Juvenile Justice Code definitions

AN ACT TO AMEND SECTION 63-3-510, CODE OF LAWS OF SOUTH CAROLINA, 1976, RELATING TO THE JURISDICTION OF THE FAMILY COURT, SO AS TO RAISE THE AGE THAT A PERSON IS CONSIDERED A CHILD FOR PURPOSES OF DELINQUENCY MATTERS BEFORE THE FAMILY COURT; TO AMEND SECTION 63-19-20, RELATING TO THE DEFINITION OF "CHILD" OR "JUVENILE" , SO AS TO MEAN A PERSON UNDER THE AGE OF EIGHTEEN YEARS, WITH EXCEPTIONS; TO AMEND SECTIONS 63-19-1030, 63-19-1210, 63-19-1410, 63-19-1420, 63-19-1440, AS AMENDED, 63-19-1850, AS AMENDED, AND 63-19-2050, AS AMENDED, ALL RELATING TO JUVENILE DELINQUENCY PROCEEDINGS IN THE FAMILY COURT, SO AS TO RAISE AGE LIMITATIONS TO CONFORM WITH SECTIONS 63-3-510 AND 63-19-20; AND TO REQUIRE CERTAIN STATE AGENCIES TO COLLECT DATA AND SUBMIT A REPORT ADDRESSING THE FISCAL IMPACT OF RAISING THE AGE THAT A PERSON IS CONSIDERED A CHILD FOR PURPOSES OF DELINQUENCY MATTERS BEFORE THE FAMILY COURT. - ratified title
