A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 38-73-737 so as to provide that automobile liability and collision insurance rates are subject to a credit if an insured has passed an approved driver training course, and to provide for the requirements of the course; and to amend Section 38-77-350, as amended, relating to conditions under which new offers for automobile insurance are not required, so as to provide those conditions when a policy is offered or issued by a new serving carrier for the South Carolina Reinsurance Facility.-amended title
