### **S\*0950 (Rat #0527, Act #0448 of 1980) General Bill, By R.C. Dennis, J.C. Lindsay and J.M. Waddell**

A Bill to amend Sections 9-11-10 and 9-11-40, Code of Laws of South Carolina, 1976, as amended, relating to the Police Officers Retirement System, so as to further define "compensation" and "employer" and to authorize certain service organizations to become employees under the system; to amend Act 97 of 1977, relating to a voluntary tax sheltered deferred compensation plan for public employees, so as to further define "employees"; and to amend Act 150 of 1979, relating to the retirement system for judges and solicitors, so as to include certain former judges and solicitors.-at
