### **S\*0961 (Rat #0730, Act #0549 of 1990) General Bill, By M.T. Rose**

A Bill to amend the Code of Laws of South Carolina, 1976, by adding Section 17-15-240 so as to allow bail bond money to be deposited in interest-bearing accounts, to provide that the interest on these accounts is public funds, to provide the distribution of the interest, and to authorize South Carolina Court Administration to prescribe procedures for handling and accounting for bail bond interest.-amended title
