Visit our Publications page for Advance Sheets, Acts and Joint Resolutions, and the Legislative Digest. Additionally, current legislation and archived legislation may be searched using multiple criteria, such as Bill Number, Primary Sponsor, Subject, Full Text and more.

The Legislative Services Agency also offers the Legislative Information Tracking System online. This service is free and may be accessed from the General Assembly's website homepage under Track Legislation on the left vertical menu bar. The tracking system includes Custom Reports, Tracking Lists and an E-mail Subscription service for House and Senate Meeting Schedules and online publications such as daily Calendars, Journals and Introduction Sheets. A valid E-mail address is required to establish an account.

All printed <u>legislative materials subscribed to must be picked up</u> from the Joint House/Senate Act Room on the first floor of the State House. <u>No material will be mailed</u>. Any material not picked up during the two-week period following notification will be removed from your file for disposal.

The attached order form for printed legislative publications for the 2025 Session must be processed by January 2, 2025 to ensure availability of materials.
