Legislative Delegations,

Pursuant to Proviso 33.9, attached is the South Carolina Department of Health and Human Services (SCDHHS) report regarding the condition of space furnished to the agency by the governing authorities of your counties. The attached report provides a brief overview of indepth site assessments and reports on the accessibility of each SCDHHS county location as required by the Americans with Disabilities Act (ADA).

I am pleased to report that many counties with identified ADA accessibility deficiencies, responded positively to the site assessment, and worked to bring their location into ADA accessibility compliance. As the counties correct identified issues, SCDHHS verifies the improvement. While there have been many improvements made to county offices, some county locations still did not meet ADA Standards. In those cases, the original barrier is still listed on the attached report.

Additionally, as required by Proviso 33.9, by May 1st, the governing authority of any county with an identified ADA-related deficiency shall report to its legislative delegation and the Director of SCDHHS on its progress in correcting identified deficiencies.
