

Fiscal Year 2025 Report Children's Hospital and Healthcare Innovation, Proviso 33.36

This Report is submitted pursuant to Section 33.36 (DHHS: Children's Hospital and Healthcare Innovation).

The South Carolina General Assembly appropriated (\$5,000,000) to establish the South Carolina Children's Hospital and Healthcare Innovation Program.

The purpose of the program is to make strategic investments to ensure that children have in-state access to state-of-the-art children's hospitals and pediatric specialty services. The South Carolina Children's Hospital Collaborative, the state children's hospital association, will annually submit for approval by the department, funding priorities for infrastructure, working in partnership with the Department of Health and Human Services to additionally identify regional or statewide pediatric specialty service priorities.
