Re: Compliance with Proviso 117.21

Dear Chairman Peeler, Chairman Bannister, and Acting Program Director Shealy:

The Fiscal Year 2023-2024 Appropriations Act directs state agencies receiving funds that are a direct appropriation to a non-profit organization to report information on what was collected from said organization(s) pursuant to proviso 117.21 to the Chairman of Senate Finance, the Chairman of House Ways and Means, and the Executive Budget Office by June 30, 2024. Please allow this letter to serve as the Department of Transportation's (SCDOT) compliance to the proviso.

In FY24, SCDOT received funds to be directed to 11 other entities. Of these 11, two appropriations were redirected to other agencies to administer. SCDOT administered the remaining nine shown in the chart below.
