January 2025 - Reporting on State Fiscal Year 2024

With a more than \$6 billion construction program and transformational projects happening in communities across the state, the South Carolina Department of Transportation (SCDOT) is entering the final quarter of the 10-Year Plan set to complete at the end of calendar year 2027. The agency continues its commitment to the Governor, General Assembly, and the citizens of South Carolina to maintain the state highway system in the highest state of good repair possible given the available funding. The agency is responsible for planning, constructing, maintaining, and operating the fourth largest state-owned highway system in the nation, as well as the development of a statewide intermodal and freight program.

Thanks to the General Assembly's action in 2017 when it passed Act 40, which diversified the agency's revenue streams and increased the state gasoline tax, plus an increase in federal funding and additional state appropriations, the agency continues to make progress in restoring the state's transportation network. Without these additional investments, our infrastructure would not be able to prepare for nor sustain the influx of people coming to South Carolina to learn what we already know: South Carolina is the best place to live, work, and raise a family.

To aid in our commitment, SCDOT uses asset and performance management principles that tie defined asset condition outcomes to specific levels of investment. This ensures our pavement and bridge assets have the longest service life possible for the least practical cost.

The state's economy is booming, and we are proud to play an active role in that advancement. Alongside our partners at the South Carolina Ports Authority who operate the 8th largest port in the United States at the Port of Charleston, we connect both it and the inland ports with major cities and commercial hubs while efficiently transferring goods and people statewide. We have focused our efforts on improving the system's condition through our existing 10-Year Plan set to expire at the end of calendar year 2027. The focused effort is intended to drive investments towards projects that result in the recovery of the system from more than three decades of underfunding while considering the future needs of the fastest growing state in the nation.

Fiscal Year 2024 was somewhat of a transition year at the department with even more opportunities to come. In April 2024, the newly confirmed Secretary of Transportation, Justin Powell, began his leadership of the agency with a nearly \$3 billion annual budget and 4,000 employees following the retirement of former Secretary Christy Hall. Shortly before Powell's confirmation, the SCDOT Commission elected its first female Chair when Pamela Christopher, of Anderson, moved into the role in January after four years on the Commission. Additionally, the General Assembly confirmed a new commissioner for the state's 5th Congressional District, Curtis Spencer, in May following the end of Commissioner Gene Branham's term.



With a new Secretary in place, the leadership team of the agency also took shape when Rob Perry became the Deputy Secretary for Engineering, Karl McCottry became the Deputy Secretary for Finance and Administration, Jennifer Necker became the Deputy Secretary for Intermodal and Freight Programs, and Allen Hutto became the Chief of Staff. Brent Rewis, the Deputy Secretary of Planning, retired in July 2024 (SFY2025) with Leah Quattlebaum being named the Interim Deputy Secretary of Planning shortly thereafter. While SFY25 will be covered as a whole in next year's Annual Report, Ms. Quattlebaum was appointed to the Deputy Secretary of Planning position in November 2024.

With new leadership, the goals of the department remain clear:

- Improve safety programs and outcomes in high-risk areas;
- Maintain and preserve the existing transportation infrastructure;
- Improve program delivery to increase the efficiency and reliability of the road and bridge network.

SECTION I - Agency Accomplishments

While the agency continues to make strides in its construction program – focusing on safety/rural roads, rehabilitating the system, targeting bridges, and investing in interstate capacity – there are dozens of other successes that speak to the men and women who make up the SCDOT team and our collective mission to keep South Carolina moving.

In July 2023, 24 employees graduated from the **year-long professional development course** called LEAD. These talented professionals spent time refining their skills while learning every facet of the agency which culminated in a project recommending improvements for employee recruitment and orientation.

Dozens of agency employees pre-positioned for **impacts from Hurricane Idalia** which impacted the Florida Coast as a category three storm in August 2023. While South Carolina's impacts from the storm were relatively minor, crews spent time as soon as it moved through to begin the recovery process of assessing damages and identifying areas where standing water or fallen trees would prevent traffic flow.

Four SCDOT employees took home awards at the Southeastern Regional RoadEO competition in West Virginia. The September 2023 event brought state DOTs together to compete in equipment-related competitions to test their skills maneuvering complex situations. Team SCDOT placed third overall.

Only a few days before Christmas in December 2023, SCDOT employees and partner contractors responded to a **settled bridge on I-20 which necessitated an immediate closure and emergency repairs**. In just more than 48 hours, the westbound bridge over the Wateree River reopened to traffic so people could safely and conveniently commute for their holiday travel. The bridge was already programmed for rehabilitation along with the replacement and rehabilitation of two additional bridges in the corridor.

Shortly after the New Year, SCDOT crews worked around the clock to prepare for multiple winter storms, one of which brought a **tornado through downtown Bamberg**. More than 90 tons of bricks and metal were collected by 44 SCDOT employees using 19 different machines to clear debris from US 301.



SCDOT employees across the state participated in the annual statewide highway litter cleanup in April. The “Spring Spruce Up” initiative brings employees together to collect litter across the state. We appreciate the motoring public’s caution around our team cleaning along the roadways.

Citizens across the state were **encouraged to engage with SCDOT** in June by participating in the Momentum 2050 Transportation Planning Survey. The survey allows citizens to provide input on the planning process for what the state’s infrastructure looks like over the next 25 years in an effort to continue building the South Carolina of the future.

SECTION II - Delivering Results with the 10-Year Plan


During SFY24, the agency broke ground on improvements forthcoming to the I-26/I-95 interchange in Orangeburg County. The project will reconstruct this major existing system interchange and provide for acceleration and deceleration lane tie-ins that will increase efficiency and reduce delays.

In February, the five-phased Carolina Crossroads project, the I-26/I-20/I-126 interchange improvements in the Midlands, was re-sequenced to accelerate widening of I-26 and I-20. The accelerated widening schedule allows those corridors to tie-in with other widening projects happening ahead of schedule. The motoring public can also see the visible progress on Phase I and Phase 2 as construction proceeds. The entire project is anticipated to be complete in the early 2030s.

State officials broke ground on improvements to SC 160 at I-77 in March. This interchange will be reconfigured with the first-of-its-kind-in-South-Carolina offset direction interchange which will reduce left-turn conflicts. The reconstructed interchange is scheduled to be open to the public in late calendar year 2027.

SCDOT opened the bridge on US 1 over I-20 to traffic in May marking a major milestone in the I-20 interchange improvement project.





To wrap up the fiscal year, the agency opened the third northbound lane on I-85 from mile marker 80 to mile marker 90 as part of the interstate's widening and improvement project.

These are a small handful of the projects that are building South Carolina for the future while even more transformational improvements happen in areas across the Palmetto State. The agency continues to have cones on the ground statewide with dozens of intersection improvements, hundreds of miles of paving, and the countless maintenance work requests that occupy our employees at every level of the agency.



Last year, the agency noted its \$4.8 billion construction program. Now, however, that program is more than \$6 billion and growing.

Rural Road Safety Program

The agency continues to make progress towards engineering rural roads to be the safest they can be through the Rural Road Safety Program which has a minimum program budget of \$50 million annually. More than **1115 miles of high-risk rural roads**, those in which collisions “resulting in fatalities and incapacitating injuries that exceed the statewide average,” have been or are being upgraded with additional rumble strips, widened shoulders, or additional reflective markers. These first projects are complete and contribute to a 20 percent reduction in fatal and serious injury crashes on treated roads. These measures provide motorists the opportunity to correct behavior behind the wheel before a collision occurs. This program, coupled with an additional \$96 million¹ in the 2024-2025 Appropriations Act, saves lives. Because of this additional investment, SCDOT amended its ten-year goal from 1250 treated miles to 1300 treated miles by the end of 2027. Since a high in CY2021, there has been a cumulative decrease in fatalities (on all roads) by nearly 15%.

Driver behavior is an external factor impacting these numbers. While the agency and its partners can work to engineer solutions for safe outcomes, behind-the-wheel behavior most greatly influences this data.

SCDOT has let 12 pedestrian or bicycle safety projects to construction and anticipates an additional eight will go to construction in SFY25. The agency has reached its 10-year target for intersections and/or high-risk locations let to construction. At the beginning of the 10-Year Plan, the agency’s goal was 125 intersections and/or high-risk locations addressed with tailored and targeted safety projects. As of April 2024, the agency has treated 185. There are an additional 27 intersections and/or high-risk locations anticipated to be let to construction by the end of SFY25.

Paving

More than 8800 miles of primary, farm-to-market secondaries, and neighborhood streets are planned, actively in construction, or completed as the agency works towards restoring the system to a state of good repair.


For decades, a lack of funding contributed to deferred maintenance on the state highway system. At the start of SFY25, SCDOT committed to investing another \$719 million into the state's pavement program – a number that would not be possible if not for the General Assembly's action passing Act 40 of 2017, colloquially referred to as "The Roads Bill." In SFY25, an additional 727 miles of roadway will be added to the 8800 miles already treated.

Interstates

Work is underway on nearly every interstate in South Carolina. With a ten-year-goal of 140 miles under contract for widening by 2027, SCDOT is well on its way to meet or exceed the goal. Currently, **more than 109 miles of these critical arteries** of commerce that support the state's economy and connect the mountains to the coast are being widened or have been since 2017.

Eventually, I-26, South Carolina's "Main Street," from Little Mountain to Charleston will be at least six lanes across. Soon, the first eight miles of I-95 coming into South Carolina from Georgia will be three lanes on each side as well, with construction anticipated to begin in early calendar year 2025.

Construction on I-85 in Cherokee County is expected to be complete by the end of fiscal year 2025.



Bridges

In SFY25, the General Assembly appropriated \$200 million to accelerate the agency's bridge program in an attempt to get ahead of the increasing number of bridges statewide that will soon be operating.



beyond their useful life. This investment will allow SCDOT to infuse an additional \$100 million to bridges on primary and interstate routes and \$100 million to bridges on secondary routes.

Because of the additional investment, the agency's 10-year goal to rehabilitation or replace old bridges went from 500 to 530 by the end of December 2027. At SFY24's close, **352 bridges were either under construction or completed**. While the agency is on track to meet its 10-year goal, the additional investment in state dollars will be used to ensure the existing problem does not turn into a future crisis.

Looking towards SFY26, SCDOT again requests a recurring \$200 million to ensure the accelerated bridge program continues so these critical connections across the state remain operational for the traveling public.

Similarly, SCDOT pursues federal discretionary grant opportunities to supplement the need for state investments where possible. As good stewards of resources, SCDOT is proud to seek all types of funding for infrastructure projects.

In early SFY25, SCDOT was awarded, at the time, the largest discretionary grant in the state's history of \$175 million for the replacement of the I-95 bridges over Lake Marion at the Orangeburg/Clarendon County lines. Additionally, SCDOT was awarded a nearly \$2 million planning grant to study the I-85 corridor over Lake Hartwell at the Georgia/South Carolina border in Oconee County to determine the best way forward on the replacement or rehabilitation of six rural bridges. Not to be outdone, only months later SCDOT received what is currently the largest discretionary grant in the state's history of \$195 million to construct a new interchange at Long Point Road and I-526 in Charleston. This project will separate vehicular traffic and truck traffic from the Port of Charleston, thus alleviating congestion. And, work continues in Union County, replacing bridges with more than \$51 million awarded in grant funding during SFY23.

The 10-Year Plan is financially backed by both state and federal funds with the allocation of funding strategically assigned to maximize efficiency and leverage all funds to their maximum potential and benefit to the state. The 10-Year Plan also embraces asset and performance management principles, including tying specific levels of investment to desired targets.

Each year, SCDOT reports on this progress and has compiled the table below in compliance with SC Code of Laws Section 57-1-380.

SCDOT fully understands the challenge of building, maintaining, and preserving the pavement and bridge assets of the state highway system today, and how this will enable the agency to rebuild that system into meeting the needs of South Carolinians now and in the future. To accomplish this, SCDOT uses the Strategic Plan, Statewide Transportation Improvement Program (STIP), Transportation Asset Management Plan (TAMP), and Statewide Multimodal Transportation Plan (MTP).

A description of each plan or program is below:



- **Strategic Plan²** is the overarching guide of our transportation vision, mission, values, and goals. The SCDOT Strategic Plan is a multi-year plan provided to all employees and continually presented to new employees at New Employee Orientations. Our statutory charge to “***build and maintain roads and bridges in and across the state and provide mass transit to the motoring public***” continues to be our purpose and therefore, our strategic plan continues as we complete and track measures for each goal. Our Strategic Plan has five goals:
 - 1: **Improve safety** programs and outcomes in our high-risk areas.
 - 2: **Maintain and preserve our existing** transportation infrastructure.
 - 3: **Improve SCDOT program delivery** to increase efficiency and reliability of our road and bridge network.
 - 4: **Provide a safe and productive work environment** for SCDOT employees.
 - 5: **Earn public trust** through transparency, improved communications, and audit compliance.
- **Statewide Transportation Improvement Program (STIP)³** is the state’s 10-year improvement program for all projects or programs receiving state or federal funding, including pavements, bridges, upgrades, freight, safety, congestion mitigation and air quality (CMAQ), transportation alternatives program (TAP), railroad crossings, planning, State Transportation Infrastructure Bank (SIB) payments, preventative maintenance and operations, and public transportation. This is reviewed every three years, but is also revised on a continual basis to reflect the latest program and project information. Heading into FFY25, the STIP transitioned from a 7-year plan to a 10-year plan. This document is project-specific.
- **Transportation Asset Management Plan (TAMP)** is a 10-year plan that focuses on programs and activities to improve business practices, asset conditions, and system performance. The TAMP uses asset and performance management principles and practices that tie defined asset condition outcomes to specific levels of investment. In other words, how we ensure that pavement and bridge assets have the longest service life possible for the least practical cost. The plan includes the condition targets that were established as part of our 10-Year Plan. This is reviewed at two-year intervals to evaluate performance targets and sets the agency’s asset investment strategies. The current plan was completed December 2022.
- **Multimodal Transportation Plan (MTP)⁴** is a 20-year long-range plan that identifies statewide, multimodal needs, forecasts investment levels, and estimates annual funding gaps. The MTP is South Carolina’s long-range transportation plan. The 2020 update includes integrated modal plans for the Interstate, Strategic Corridors, Public Transit and Human Health Service Coordination, Freight, and Rail. This is updated every five-years. SCDOT is on track to publish the new MTP – Momentum 2050 – in early calendar year 2025.

SECTION III - 5-Year Plan Detailing Traffic Regulation

Section 57-3-760(3) of the South Carolina Code of Laws requires SCDOT to include “a five-year plan detailing the regulation of traffic which includes the administration and enforcement of traffic, driver, and motor vehicle laws and other laws relating to such subjects, the coordination of state and federal

programs relating to mass transportation among the departments, agencies, and other bodies politic and legally constituted agencies in the State."

However, Act 181 of 1993 (also known as the 1993 Restructuring Act) dissolved the Highway Department into the Department of Public Safety, the Department of Motor Vehicles, and the Department of Transportation. Section 57-3-110 outlines the duties and powers of SCDOT which does not include the regulation of traffic nor the enforcement of driver and motor vehicle laws. Thus, this is not the responsibility of SCDOT and is not included in this Annual Report.

SECTION IV - Firms, Companies, & Businesses with Contracts

The following are lists by five categories of all firms, companies, or businesses that did business with the South Carolina Department of Transportation during SFY 2024 (July 1, 2023 – June 30, 2024).

The first report is ***All Vendor Payments*** and begins on page 13. This report includes all payments made to any vendor during SFY24 and is sorted from highest paid vendor to lowest.

The second report focuses only on ***Construction Contracts***. The Construction Contracts report begins on page 76 and reflects the total contract amount for contractors working on the state highway system. This report does not show what has been paid to each contractor, simply the total contract amount.

The third report focuses only on payments associated with work to construct, renovate or maintain SCDOT owned buildings. The ***Facility/Capital Improvements*** report is on page 78.

The fourth report focuses only on payments for vendor services generally affiliated with maintenance and operation of the state system as well as general supplies. The ***Commodities and Services Contracts*** report begins on page 78.

The fifth report focuses only on payments for engineering consultants and other professional services. The ***Professional Services Contracts*** report is on page 83.

Finally, the sixth report reflects payments for ***Small Purchases*** (page 84). In previous years, this report was combined with the ***Commodities and Services Contracts*** report.

Section 12-28-2930 of the Code of Laws and Article 8 of Chapter 63 of the Code of Regulations requires the Department to ensure at least ten percent of state-source highway funds are expended through direct contracts with estimated values of \$250,000 or less to small business owned or controlled by socially and economically disadvantaged ethnic minorities (MBEs) and firms owned and controlled by disadvantaged females (WBEs), collectively, these groups are referred to as "Disadvantaged Business Enterprises" or "DBEs." In SFY24, no contracts were awarded under the State DBE Program as specifically set forth in Section 12-28-2930(I).
