

# Overview

## FINANCIAL SUPPORT OF COUNTY BOARDS

The State of South Carolina has provided substantial financial support to county boards of voter registration and elections through the SEC’s budgetary process. Since July 2019, the SEC has spent approximately \$109 million in county aid. This includes over \$78 million for voting equipment, \$26 million in reimbursed election expenses, and \$2.9 million in county board member stipends. Of these expenditures, only election expenses and board member stipends are mandated by state law. Had the state not purchased voting equipment and provided it directly to county governments, counties would have been required to procure their own equipment, and the full \$109 million would have been carried by county budgets.

## ELECTION AUDITS

In 2025, hand-count audits were performed across multiple special primary, runoff, and general elections including:

- + House District 113 Special Primary (Charleston County): 803 total ballots, 87 hand-counted (11%).
- + House District 113 Special General (Charleston County): 403 total ballots, 62 hand-counted (15%).
- + House District 50 Special Primary (Kershaw, Lee, and Sumter Counties combined): 2,877 total ballots, 353 hand-counted (12%).
- + House District 50 Special General (Kershaw, Lee, and Sumter Counties combined): 3,698 total ballots, 440 hand-counted (12%).
- + House District 21 Special Primary (Greenville County): 2,212 total ballots, 407 hand-counted (18%).
- + House District 21 Special Runoff (Greenville County): 3,066 total ballots, 648 hand-counted (21%).
- + State Senate District 12 Special Primary (Greenville and Spartanburg Counties combined): 5,008 total ballots, 985 hand-counted (20%).
- + House District 88 Special Primary (Lexington County): 1,488 total ballots, 179 hand-counted (12%).
- + House District 88 Special Runoff (Lexington County): 2,636 total ballots, 883 hand-counted (34%).
- + House District 98 Special Primary (Dorchester County): 3,342 total ballots, 274 hand-counted (8%).
- + House District 98 Special Runoff (Dorchester County): 1,412 total ballots, 572 hand-counted (41%).





## TRAINING

### South Carolina State Certified Clerk Program

- + Conducted three cohorts of three-day extensive training with 65 clerks representing 21 counties.

### General Election Preparation

- + Conducted 20 training sessions across six counties to train poll managers and poll clerks.
- + Supported counties by serving as poll managers and office staff during City of North Augusta General Election, State House District 50 Primary, Spartanburg County Sheriff Special Election, State House District 88 Primary, and Municipal Election Day across 10 counties.

### South Carolina Association of Registration and Election Officials (SCARE)

- + Delivered training sessions to county board members, county directors, and county staff at the 2025 SCARE conference.

### Training Classes

- + Conducted two regional training sessions in Berkeley, Greenville, Georgetown, and Pickens.
- + Conducted 75 training classes for county board members, county directors, and county staff.

## ELECTION SECURITY

Elections face numerous threats from a wide variety of actors with various motives. The agency collaborates with a partnership of state, federal, and private cybersecurity professionals, as well as state and federal law enforcement, to take all reasonable measures to ensure the security of South Carolina’s Election Infrastructure.

### Major 2025 Achievements:

- + Vulnerability Disclosure Program: The SEC continues to participate in the Vulnerability Disclosure Program (VDP). A VDP is a formalized process for identifying and remedying potential cyber vulnerabilities identified by external security researchers.
- + Endpoint Protection: The SEC continues to utilize CrowdStrike Endpoint Protection System to enhance the agency’s ability to identify, detect, respond to, and remediate security incidents and alerts.
- + Physical Security Assessments of County Offices and Storage Facilities: The SEC, in collaboration with the Department of Homeland Security (DHS), continues to conduct physical security assessments of facilities across all 46 counties, on an as-needed basis or at the request of county offices.
- + Security Posture Baseline: The SEC continues to survey counties based on National Institute of Standards and Technology (NIST) standards to identify their current security posture.
- + The SEC has obtained membership in the Multi-State Information Sharing and Analysis Center (MS-ISAC) to ensure the continued delivery of critical information related to election security.

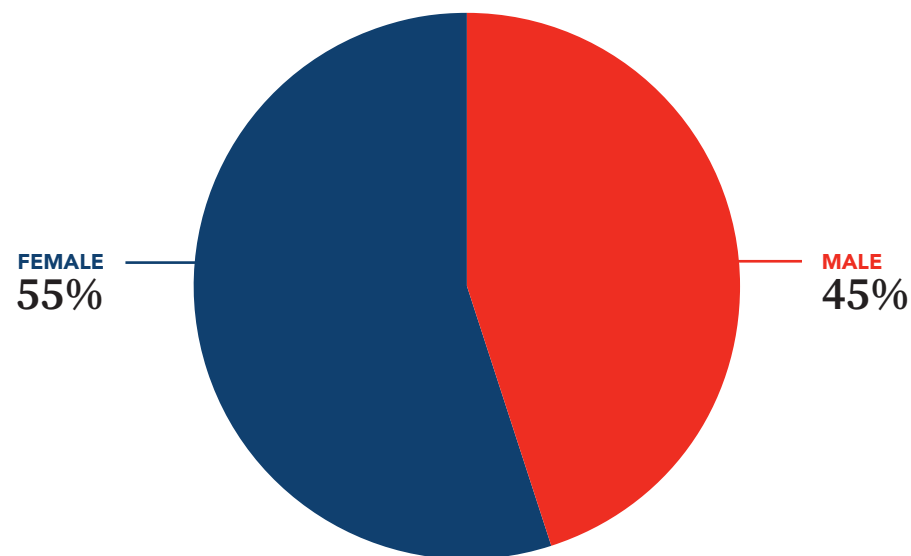

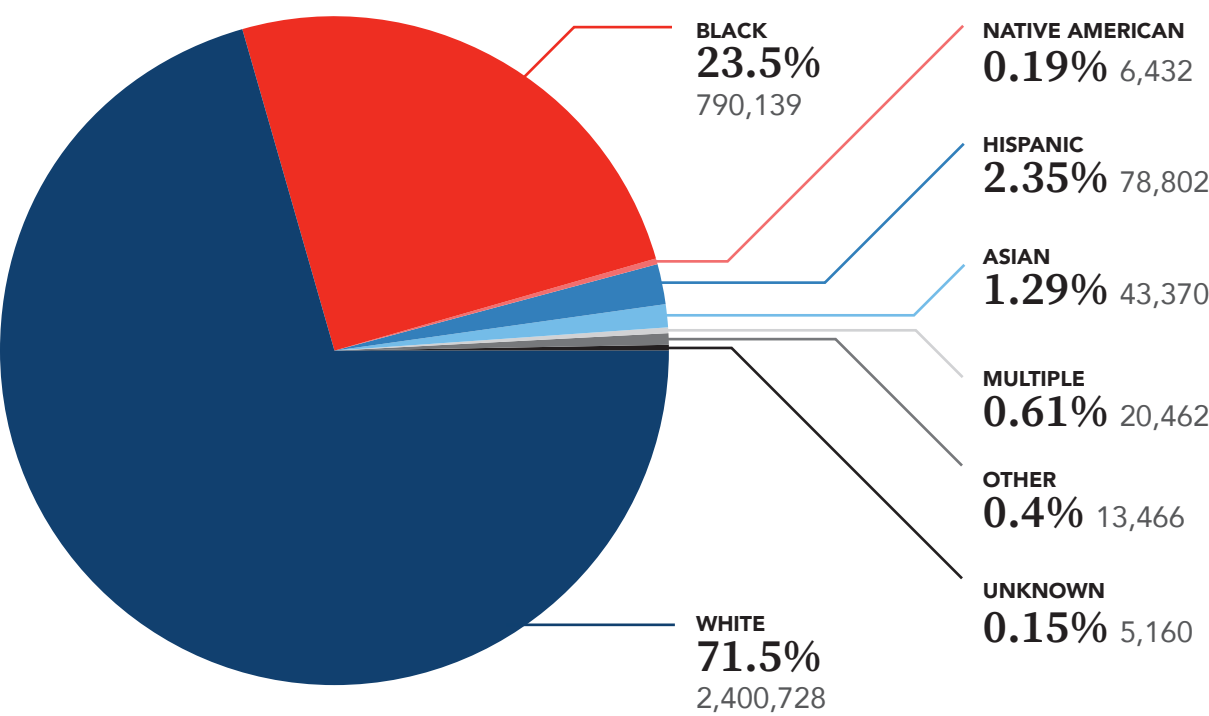

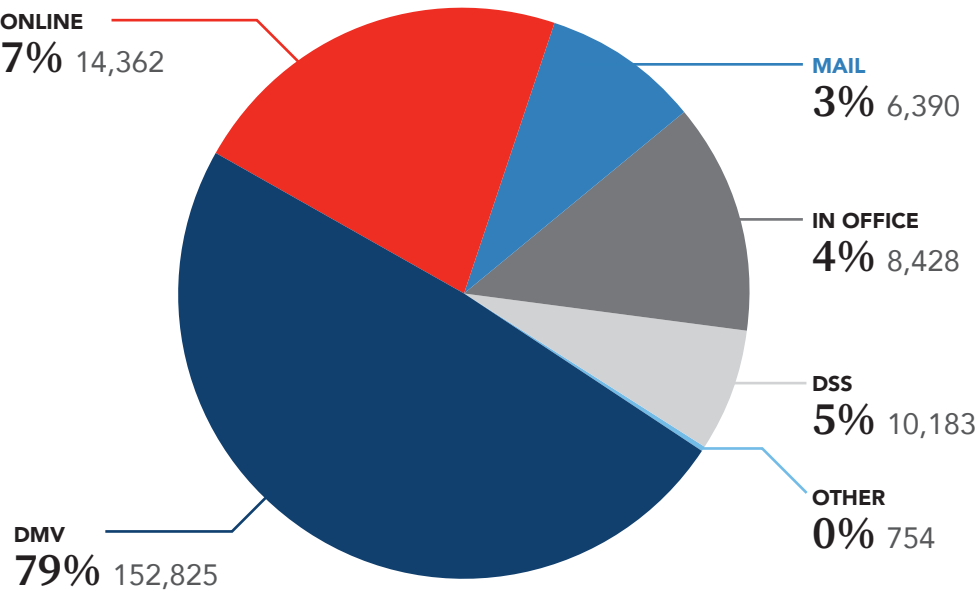
