NOTE: The Domestic Violence Reform Act (S.C. Act No. 58 (R80, S3)), which went into effect on June 4, 2015, placed the crimes of “criminal domestic violence” with the crimes of “domestic violence.” Only conduct occurring prior to June 4, 2015 is prosecuted as “criminal domestic violence” crimes, and no such crimes were prosecuted in General Sessions Court in any judicial circuit during FY 24 and FY 25.
