Please be advised that Spartanburg County and our office was struck by ransomware on April 27, 2023. This attack has crippled our case management system and the ability to run reports, compare data has been affected. Any numbers or statistics we have been able to collect and provide have been from Court Administration's reports. Using these numbers, we are unable to create detailed reports as we have done in the past.

In addition to our case management system, many of our employees' End User folders were struck and all information saved was destroyed. Included would be spreadsheets primarily used for the DUI and Domestic Violence information you have asked for on many of the reports.

Unfortunately, this is something that is beyond our control and our struggles continue daily. We are in the process of initiating a new case management system (Matrix), but it is in the early stages and many functions are still incomplete and unusable currently.
