Please explain how these funds will be used to provide a public benefit:

The Alternative to Incarceration (ATI), or Jobs Not Jail initiative provides family court judges an option to use at initial contempt hearings for unemployed or underemployed non-custodial parents. This initiative provides an alternative sentencing strategy for low-income fathers who are behind in the payment of child support. Fathers who are court-ordered to attend a fatherhood program must work, must pay both their ongoing and debt-related child support, and must attend a weekly support group on the core fatherhood curriculum for 24 weeks. Unlike jail, however, low-income fathers who have little education or job skills are also given the necessary support services to provide financially for their children well into the future.
