# **AGENCY'S DISCUSSION AND ANALYSIS**

In an effort to protect the safety, integrity, and security of statewide public resources, infrastructure, data, and citizens; SLED continues to fulfil its mission of providing quality manpower and technical assistance to law enforcement agencies of political subdivisions of South Carolina and to conduct investigations on behalf of the state as directed by the Governor or Attorney General. SLED also continues its effort to fully realize its vision of being the premier law enforcement agency in the State of South Carolina so as to insure that every citizen in South Carolina is provided an equal level of law enforcement services. However, in some ways, it seems that SLED is a victim of its success in this endeavor because requests for SLED assistance has increased substantially across the State of South Carolina and SLED is concerned about having the manpower and resources capable of responding to these increased needs.

Across the State of South Carolina, law enforcement agencies are having difficulty retaining sworn law enforcement officers. The South Carolina Criminal Justice Academy reports that 7% of all recruits leave the law enforcement profession in the first year and 54% leave the profession in five years. As such, there are high vacancy rates in local departments throughout the State. As a result, the requests for SLED assistance have and are likely to continue to increase.

By way of example, in the calendar year 2013, SLED's Protective Services and Emergency Management Unit coordinated the usage of 174 agents to handle 61 events. In 2018 alone, the number of agents needed increased to 1,517 to handle 81 events. Given the upcoming hurricane season and the 2020 election cycle, SLED anticipates its requests for service to continue to increase and will ultimately need additional manpower to accommodate these ever-increasing requests.

### **Investigative Services Unit**

SLED is committed to providing quality investigators to handle the ever-increasing amount of criminal investigations in the State, including some of the most complex and time-consuming cases, in as timely a manner as resources allow. To that end, SLED's Investigative Services division is comprised of four regional offices around the State (located in Columbia, Florence, Greenville, and Walterboro); SLED's Vehicle Crimes Unit; SLED's Behavioral Sciences Unit; SLED's Special Victim's Unit (comprised of Vulnerable Adult Investigations Unit, Child Fatality Investigations Unit, and Forensic Art); SLED's Polygraph Unit; SLED's State Grand Jury Investigations Unit; and SLED's Training Unit. In 2018 alone, this unit handled 42 officer-involved shooting cases, which are often the most visible and publicly scrutinized cases in the State; 59 official misconduct/public corruption cases that are also highly publicized and complex; 84 homicide or death cases and 69 criminal sexual assault cases (it is noteworthy that SLED's regional investigators are the primary major crimes investigators for a number of smaller jurisdictions around the state); 325 vehicle crimes cases; 171 threat cases and assessments; 899 SVU intakes resulting in 403 cases being opened; and 177 polygraphs. In addition, SLED participated in various federal and state task forces in an effort to best coordinate and communicate with all federal, state, and local investigative partners. Moreover, SLED currently supports two full-time Victims' Advocates to assist victims of crime as needed.

# **Counter-Terrorism Operations Unit**

SLED's Counter-Terrorism Operations Unit is comprised of SLED's Arson Investigations Unit, SLED's Protective Services and Emergency Management Unit, SLED's Maritime Response Unit, SLED's Bomb Squad, SLED's SWAT Team, SLED's Aviation Unit, SLED's Bloodhound Tracking Team, and SLED's WMD Team. SLED's arson unit provides subject matter expertise to assist both law enforcement and fire service entities with fire origin and cause investigations throughout South Carolina. This unit continually maintains a case closure rate that vastly exceeds the national average for case closures. SLED's Protective Services and Emergency Management Unit utilizes SLED personnel from the entire agency to assist with securing the various events occurring in South Carolina, including Memorial Day Bike Week, the Charleston Bridge Run, University of South Carolina and Clemson Football games, rallies at the Statehouse, other statewide festivals, events security details, and armed escorts for the Department of Energy. In addition, this Unit coordinates with the South Carolina Emergency Response Division to provide personnel to ESF-13 during natural disasters and for training exercises and preparation for the same. The Maritime Response Unit protects South Carolina's maritime infrastructure through explosive, radiological, and hazardous device detection sweeps and the mitigation of incidents related to such. In addition, this unit supports federal, state, and local partners in the Port of Charleston and other maritime environments. SLED's bomb squad unit provides subject matter expertise to all law enforcement agencies, including in South Carolina and for other major events occurring outside South Carolina (including the Super Bowl, the Boston Marathon, and Party Conventions). This unit conducts protective sweeps for events and potential targets as well as responds to SWAT calls, bomb threats, and ordinance disposal requests. In addition, this unit provides and participates in explosive and/or hazardous materials related training for bomb techs at the federal, state, and local levels. SLED's SWAT Team provides tactical expertise and specialized response capabilities throughout South Carolina. The focus of this unit remains responding quickly, utilizing tactical solutions, and mitigating casualties through specialized training, equipment, and tactics to protect all citizens in South Carolina. This unit responds to barricaded subjects/hostage situations, assists with high-risk warrant service operations, and provides response capabilities to special events throughout the State. In addition, SLED SWAT sends personnel to assist the City of Myrtle Beach every weekend from Easter through Labor Day. The SLED Aviation Unit provides 24-hour a day aviation support and assistance to all law enforcement entities in South Carolina. This unit assists with the location of missing persons, fugitive apprehension, narcotics operations and eradication efforts, surveillance operations, tactical operational support, and natural disaster assistance. SLED's Bloodhound Tracking Team is a specialized tactical unit the uses bloodhound-mix tracking dogs to assist federal, state, and local partners in locating wanted and missing individuals. This unit also provides support for SWAT operations, fugitive apprehension operations, and searches. In addition, this unit is also committed to promoting public relations as SLED's bloodhounds are beloved. SLED's WMD Team supports our federal, state, and local partners in responses to chemical, biological, radiological, nuclear, and explosive (CBRNE) related events in South Carolina.

As is evident from the variety and complexity of the tasks set forth above, SLED's Counter-Terrorism Unit is in increasingly high demand and the manpower needs for this unit continue to grow every year. In order to continue to serve South Carolina and fulfill SLED's mission, this unit will continue to require additional manpower and resources.

# **SLED's Forensic Services Laboratory**

SLED's Forensic Services Laboratory is an internationally accredited full service crime laboratory that serves criminal justice agencies throughout South Carolina. SLED has vastly outgrown its current facility and the space limitations have greatly impacted efficiency and capacity. Lack of appropriate work space for current employees limits their efficiency and limits SLED's ability to seek additional staffing to provide timely case completions. As such, SLED was fortunate to receive funding in the FY 2018-2019 appropriations act to construct a new state-of-the-art facility. The new facility will allow for the consolidation of all forensic departments in a single structure and the new modern design template will allow for increased flexibility to handle future trends in forensic testing and analysis, as well as to alleviate the lack of space for evidence storage. SLED is committed to continue the efficient and timely construction of this new facility and continues to complete the planning and design phase of this project.

While undertaking the planning and coordination of construction, this Unit continues to work towards reducing backlogs and turnaround times for testing. However, the sheer volume of cases and assignments make this effort more difficult. In the past 5 years, SLED has received 122,890 cases and has seen a 22% increase in cases received, a 28% increase in the individual case assignments, and a 9% increase in items received. Drug submissions related to marijuana and hemp have resulted in a 247% increase in the Drug Analysis backlog. In addition, the recent implementation of STRMix has dramatically increased SLED's ability to interpret DNA mixtures. However, the analysis and interpretation required for such is more time consuming. In addition, STRMix has allowed SLED the capability to renew interest in cold cases and previously unanalyzed mixtures on otherwise closed cases. As such, SLED's expanded capabilities have resulted in a decrease in case output, yet these same capabilities have resulted in solving previously unsolved crimes and have absolutely advanced the cause of justice in South Carolina.

Forensic Services contains a number of specialized program areas. SLED's Computer Crimes Center (SC3C) provides expertise throughout South Carolina in the examination and analysis of electronically stored information contained on a wide variety of data storage devices. SLED's Crime Scene Unit responds with technical expertise to assist statewide with the investigation of crime scenes. Last fiscal year, SLED's crime scene unit completed 276 crime scene summaries. SLED's DNA Casework Department performs analysis on biological evidence, and completed 3,077 cases last year. SLED's DNA Database Department manages the Combined DNA Index System (CODIS), which is the national database containing DNA profiles of qualifying DNA samples. In the previous fiscal year, this department uploaded 16,713 new samples and reported 695 DNA "hits" to law enforcement agencies for investigative purposes. SLED continues to work with all local detention centers to provide qualifying arrestee samples. SLED's Drug Analysis is responsible for determining the presence, identity, and quantity of controlled substances in South Carolina. In the past fiscal year, this Department completed 8,429 cases with a total of 21,110 items. SLED's current projections are to vastly exceed these numbers in the next fiscal year due to the influx of marijuana cases throughout the State of South Carolina. SLED's Evidence Control Department is the first step for evidence in the Lab. Over 25,000 assignments are received by this department annually and this number is expected to increase substantially. In fact, SLED is experiencing an intake backlog due to the sheer volume of new cases coming in.

SLED's Firearms Department examines firearms and microscopically compares fired ammunition components, tools and tool marks, and operates the Integrated Ballistics Identification System (IBIS). SLED has developed the model program IBIS-by-appointment program that other federal and state partners are seeking to emulate. SLED's Forensic Technology Department administers SLED's iLab program for pre-logging evidence and sharing reports to criminal justice partners. This Department also administers SLED's Laboratory Information Management System (LIMS), which recently underwent a massive update and overhaul. SLED's Implied Consent Department regulates the breath testing program for South Carolina. A total of 21,701 breath tests were conducted in 2018. The Latent Print Department conducts analysis and examination of latent prints for criminal justice purposes throughout South Carolina. In the past fiscal year, this department completed over 1,597 cases. SLED's Toxicology Department is responsible for the analysis of biological fluids and tissues for the presence of alcohol, drugs, and poisons in postmortem, DUI, and criminal sexual assault cases. In the last fiscal year, this department completed 4,818 cases. SLED's Trace Evidence Department analyzes a variety of categories of evidence, including explosives analysis, fiber analysis, fire debris analysis, glass analysis, gunshot primer residue (GSR) analysis, paint analysis, and general physical and chemical analysis. department completed 946 cases in the last fiscal year.

SLED is committed to continuing its goal of reducing turn-around times and backlogs, especially for violent crimes, criminal sexual assaults, and GSR cases. SLED is also committed to improving the timeliness of reporting of all cases, especially reports related to officer-involved shooting investigations. The continuation of the construction of the new laboratory will certainly assist; however, additional manpower and resources are vital to this effort.

#### **SLED's Vice Unit**

SLED's Vice Unit is comprised of SLED's Alcohol Enforcement, Licensing and Vice Services Unit, and SLED Narcotics and Vice Services Unit. The Narcotics Unit assist federal, state, and local law enforcement agencies in investigation of illegal activities pertaining to the interdiction of narcotics and other illicit substances. The Alcohol Unit fills both a regulatory and enforcement function regarding the laws and regulations governing alcohol in South Carolina and is committed to increasing the number of inspections and underage purchase attempt operations conducted. SLED has also devoted additional resources to assisting the City of Columbia in addressing alcohol violations in the 5-Points area of Columbia. Vice has also created a team of agents who, as a secondary responsibility, investigate Human Trafficking crimes. This team investigates requests of Human Trafficking by the SC Attorney General's Office and tips from the National Human Trafficking Hotline. In addition, agents from this team have joined State and Federal Human Trafficking Task Forces. Agents will continue to foster relationships with local and federal agencies who focus on Human Trafficking investigations. This unit also participates in opioid taskforces and collaborates with other federal, state and local agencies to coordinate law enforcement strategies in an effort to fight the opioid epidemic in our state. In addition, this unit is committed to increasing the number of prescription drug takeback events. The Narcotics Unit also continues to encourage new partnerships and strengthen existing ones with federal, local, and state law enforcement agencies to share intelligence, strategies, and resources in order to provide a more comprehensive approach to combating narcotics trafficking, which is inherently dangerous and violent and negatively impacts our state.

#### **SLED CJIS**

SLED Criminal Justice Information Systems (CJIS) operates and maintains a central, statewide criminal justice database and data communication system and collaborates with other federal, state, and local agencies. SLED-CJIS serves as the central state criminal justice information repository and collects, processes, stores, and disseminates crime data and criminal identification and record investigation, which is vital to crime prevention and the administration of justice in South Carolina. SLED-CJIS includes the Automated Fingerprint Identification System (AFIS) unit, the Computerized Criminal History (CCH) unit, the Expungement unit, the Disposition Research Unit (DRU), the Public Dissemination Unit, the National Crime Information Center (NCIC) unit, the Sex Offender Registry (SOR) unit, the Agency Coordinator Unit (ACU), the South Carolina Information Exchange (SCIEx) unit, and the South Carolina Incident-Based Reporting System Unit (SCIBRS). In 2018 alone, AFIS processed 193,311 criminal fingerprint cards and added 294,813 arrest charges to criminal history records in South Carolina. This unit also performed 121,011 fingerprint-based background checks for employment and licensing purposes for positions of public trust across South Carolina. The CCH Unit worked towards the accuracy of SLED's criminal history records by manually entering 39,888 dispositions, setting appropriate gun flags and ensuring the accuracy of SLED's criminal history records. SLED's Expungement Unit received 87,968 expungement orders, processed 505 pardons, and evaluated 2,629 DNA expungements applications. The Public Dissemination unit reviewed, logged, and prepared 47,613 record requests and 61,119 license or permit applications. It also processed 536,186 background checks through the SLED Citizen Access To Criminal History (SLED CATCH) records in 2018. The NCIC unit audited 158 criminal justice agencies and 12 non-criminal justice or civilian fingerprint agencies in 2018 and taught 79 different NCIC classes throughout the State. The SOR unit maintains the South Carolina Sex Offender Registry Tool (SORT) system to manage South Carolina's 10,401 sex offenders. This unit also trained and audited the 50 agencies in South Carolina who register sex offenders. The ACU vetted 1,470 employees and 56 companies in 2018, representing a 194% increase in such check from the prior year. SCIEx is an online repository of law enforcement records, including incident reports that can be accessed and shared by participating law enforcement agencies. SLED-CJIS updated the SCIEx software platform utilized for this repository in 2018, and SLED continues to encourage more agencies to take advantage of this capability. SCIBRS collects and analyzes the data needed to publish the annual Crime in South Carolina publication and collected information on 355,209 incidents and 168,634 arrests related to such.

SLED-CJIS continues to work with law enforcement agencies to obtain arrest information as quickly as is possible. This unit also works across the criminal justice landscape to improve the percentage of arrests that have dispositions and to increase the number of agencies participating in SCIEx, GangNet, and CrimeNtel.

#### **SLED's Fusion Center**

SLED also operates the South Carolina Information and Intelligence Center (SCIIC), commonly referred to as the Fusion Center. This Center utilizes expertise and resources to collaborate with federal, state, and local law enforcement agencies, as well as private sector security partners, to provide intelligence-specific and analytically-driven products to all segments of South Carolina to protect critical infrastructure and detect, prevent, and respond to criminal and terrorist activity. personnel operate the Threat Analysis Cell, which provides analytical support for various threats in South Carolina and across the nation; the Interagency Operations Center (IOC) that integrates the capabilities to address threats associated with the maritime community; the Criminal Analysis Team (CAT) that processed over 13,512 intelligence requests from federal, state, and local agencies in 2018; the Amber Alert and Missing Person programs in South Carolina; and the State Surveillance and Intelligence Team which provides personnel to assist with fugitive apprehension, locating missing and endangered persons, and gathering intelligence to support Fusion Center operations. The Fusion Center also posts SCIIC bulletins and is committed to increasing the law enforcement entities and the access to SCIIC bulletins to other criminal justice agencies, critical infrastructure/private sector partners, and public safety entities in South Carolina.

#### **SLED's Office of Homeland Security**

SLED operates an Office of Homeland Security Unit. This unit administers grants received from the United States Department of Homeland Security; provides statewide active shooter/active threat training to law enforcement, fire, EMS, schools, churches, and businesses; provides coordination for statewide Critical Infrastructure/Key Resources (CI/KR) services through such entities in South Carolina; provides coordination of 37 statewide Regional Response Teams (SWAT, Bomb, HazMat, RMAT, IMT, USAR, and CSAR); provides facilitation for statewide Weapons of Mass Destruction (WMD) training to first responders; and facilitates WMD training exercises. In the past fiscal year, this unit managed 142 sub-grants. The Active Shooter/Active Threat trained 13,132 individuals and provided 111 instructor certifications in South Carolina. CI/KR personnel performed site visits, represented SLED at the statewide meetings, and conducted briefings. The unit also facilitated training for over 1,400 statewide personnel in the last fiscal year. This unit also enhanced the DHS cyber monitoring program by adding additional capabilities and growing the number of local government and CI/KR partners. The unit provides continuity of critical monitoring capabilities and ease of access into the program for additional entities, strengthening the security posture of each entity and enhancing the overall cybersecurity of critical state resources.

### **SLED's Regulatory Services Division**

The Regulatory Services Division is comprised of the Regulatory Enforcement unit, the South Carolina Law Enforcement Assistance Program (SCLEAP), SLED's Community Relations unit, and SLED's NICS unit. Regulatory maintains the responsibility for investigative and enforcement matters pertaining to licensed private security companies and registered private security guards, private investigation companies and registered private investigators, State Constables, and Concealed Weapons Permits (CWP) in South Carolina. The NICS unit also serves as the South Carolina repository for information related to federal and state firearms prohibitions, including disqualifying mental health adjudication information. SCLEAP is the finest program of its kind in the country and offers unmatched support services for South Carolina's first responders and their families.

SLED is determined to maintain its level of customer service in all of its regulated areas and is dedicated to continuing its commitment to improve NICS reporting in conjunction with the FIX NICS Act and South Carolina's state implementation plan for such.
