

## **AGENCY’S DISCUSSION AND ANALYSIS**

### **Plan it.... Do it....**

In higher education, as in other industries, organizations are often adept at either planning or doing, but frequently not both. It goes without saying that there is no progress without making and implementing decisions (doing). Meanwhile, making decisions without a long-term plan can impede progress. A quick web search results in a multitude of strategic plans, but almost no implementation models to inform decision-making and doing. Many times institutions update strategic plans annually or even less often without intentionally focusing on the plan to engage in strategic decision-making throughout the year. Instead, decisions are made off the cuff based on instinct, convenience, or past experiences.

The University of South Carolina Beaufort (USCB) is committed to maintaining its course and achieving its goals. For that reason, the USCB Strategic Plan 2023 was developed in 2017/2018 to provide a clear direction and measurable outcomes for the University. In 2018/2019, USCB undertook significant initiatives to establish and implement a clear path to inform decisions and achieve the University’s goals. These initiatives included:

- Convening Strategic Plan Implementation Subgroups;
- Developing an Academic Master Plan; and
- Planning for future academic programs.

### ***Strategic Plan Implementation Subgroups***

The University has convened Strategic Plan Implementation Subgroups—multidisciplinary and cross-departmental monitoring teams—for each of the 11 objectives under the 5 strategic goals of Strategic Plan 2023.

#### **Cultural Appreciation**

**Goal: Enhance the diversity and inclusivity of the University community.**

Objective I: *Cultivate a more inclusive and diverse environment where students feel free to discuss ideas and broaden their cultural perspective.*

#### **Academic Excellence**

**Goal: Expand and enhance the rigorous, experiential academic environment.**

Objective I: *Strengthen and develop academic opportunities to meet the needs of a dynamic and changing world.*

Objective II: *Offer experiential learning so every graduate will have at least one internship, research, service learning, or applied learning experience to enhance career preparation.*

Objective III: *Support faculty development, research, and scholarship to promote excellence and innovation.*

These teams are identifying, clarifying, and revising KPIs as necessary; aggregating and disaggregating assessment data related to the objectives; reporting findings from KPI and assessment data analyses to University administration through three meetings annually with the Chancellor’s Cabinet; and ensuring that plans are developed and implemented to achieve the objectives. The results of the teams’ work provides a more complete blueprint for discussion and decision-making.

**Academic Master Plan**

In alignment with the USCB Strategic Plan 2023, the academic enterprise at USCB, must be intentional about identifying priorities for the coming years. The Academic Master Plan (AMP) complements the University’s vision, mission, and strategic plan and articulates how the academic enterprise proposes to meet the needs of students and the region. The AMP reaffirms the existing USCB priorities of retention, experiential learning, global learning, and Honors education.

In today’s global, technology-driven, high-speed economy, computers are becoming increasingly adept at human capabilities. Disruptive technologies such as artificial intelligence, automated manufacturing, and predictive modeling are eliminating traditional jobs and creating new ones. USCB graduates must possess creativity, adaptability, and the capacity for continual learning in order to thrive and lead in the “new economy.”

In addition to rapidly changing technologies, universities are also challenged by increased competition for students and funding, a projected decrease in the number of high school graduates nationally, and growing skepticism about the value of a college degree. Enterprising institutions are meeting consumer demand with alternative modes of delivery such as open courseware, “just-for-you”

delivery, accelerated classes, learning modules, and stackable credentials that challenge traditional higher education models. Institutions that are unwilling or unable to be forward-looking and entrepreneurial in design and delivery risk becoming irrelevant.

Perhaps the most fundamental objective of the University is to “strengthen and develop academic opportunities to meet the needs of a dynamic and changing world” (USCB Strategic Plan 2023). How the University responds to and anticipates technological advancements will play a significant role in its future. The success of academics at USCB will be a function of our creativity, dynamic energy, and adaptability.

**A Diverse Community of Scholars Capable of Learning Anything**

Equipped with the understanding that educational attainment is the single greatest determiner of socioeconomic mobility, USCB will strive continually to increase the viability, access, and relevance of higher education in the Lowcountry. As a student-centric university, decisions will be based on what benefits the students, and success will be evaluated by the success of the students. ***Academic Program Planning***

To fulfill USCB’s Mission, Vision and Strategic Plan, it is essential that the University deliver a robust selection of academic programs aligned with the demands of industry, the community, and the State of South Carolina. Academic units must ensure that programs are current, innovative, and provide high-impact learning experiences.

As outlined in the USCB Strategic Plan 2023, the institution has undertaken initiatives to “identify areas of growth, and recommend new programs in consultation with program representatives and community/industry leaders.” As part of the academic planning process, the institution has endeavored to lay out its programmatic priorities for the next several years. Academic programs must be responsive to market demand and community needs. Review of prospective programs is based on 1) workforce demand, 2) financial viability for the institution, and 3) current and projected resources for implementation.

The University is actively pursuing plans for increasing academic programming space on the Bluffton campus. In the meanwhile, the University must look to the Beaufort and Hilton Head campuses to accommodate growth of existing programs and development of future programs. Each of USCB’s campuses has unique characteristics in terms of population, resources, physical attributes, and workforce needs. To this end a representative from each campus was charged with leading a study to provide recommendations regarding academic programming for each of their respective campuses.

After review with regards to workforce demand on regional, state and national levels—in addition to cost and projected enrollment—more than 40 academic program areas were divided into two categories—“feasible” for implementation or planning during the next five years and “less feasible”. Academic schools and departments are creating concentrations, minors, and majors focused on these programmatic areas that will be submitted for approval in the future.

**Risk Assessment and Mitigation Strategies**

As reflected in the USCB Mission statement, the University exists for two groups: its students and the citizens of the Lowcountry of South Carolina. This dual aim defines the fundamental mission of universities historically. Thus, at the core of its mission, the University strives for two things: to graduate a well-prepared student and to enhance the quality of life in its service area. If USCB were unable to continue growing its academic programs, enrollments, and continuing education, artistic, and cultural offerings, the impact on the people of the region and the state would be significant. The quality of life in the region would be greatly diminished as the availability of qualified employees entering the workforce would decrease, continuing education and lifelong learning opportunities would become practically non-existent, and cultural activities that are crucial to the region’s residential and tourist appeal would be significantly cut.

Necessary key interventions of the General Assembly that would help prevent such a catastrophe center on financial and capital support. Historically, USCB has received the lowest state appropriations per in-state student FTE of all SC comprehensive institutions. This is in part an artifact of insufficient state appropriation increases as the institution transformed from a two-year campus to a comprehensive university. Despite the lack of parity, research conducted by Dr. Robert T. Carey, director of the Regional Economic Analysis Laboratory at Clemson University, and Dr. John Salazar, former director of the Lowcountry & Resort Islands Tourism Institute at USCB, estimated USCB’s total economic impact in Beaufort County at \$122.4 million. For comparison, that was more than Beaufort County’s total budget for fiscal year 2017. The University’s impact is significant despite the fact that state funding for the 2018 fiscal year only accounted for about 8% of the University’s annual budget. Clearly, this is below the level needed to ensure USCB’s ability to continue fulfilling its mission. Similarly, to continue meeting the demands of USCB’s growing student population, the state provided capital support for the expansion of the campus library facility to create classroom and laboratory space and addition faculty office space needed on the Bluffton campus. Without the space required to educate additional students, it will be impossible for USCB to admit a sufficient number of students to fill the region’s education gap.

Despite the strain of committing to expansion in order to meet the needs of its constituents, USCB will continue to support the region’s more than 220-year commitment to affordable higher education. The Lowcountry of South Carolina shows no signs of curtailing its growth, and USCB will forever remain a key partner in the success of the region, the state, and the nation. While USCB is committed to diversifying its revenue sources and reducing overhead expenditures, additional appropriation and capital support from the state will be essential for USCB to grow and maintain robust student enrollments on each of its unique campuses located in Bluffton and Beaufort and on Hilton Head Island.

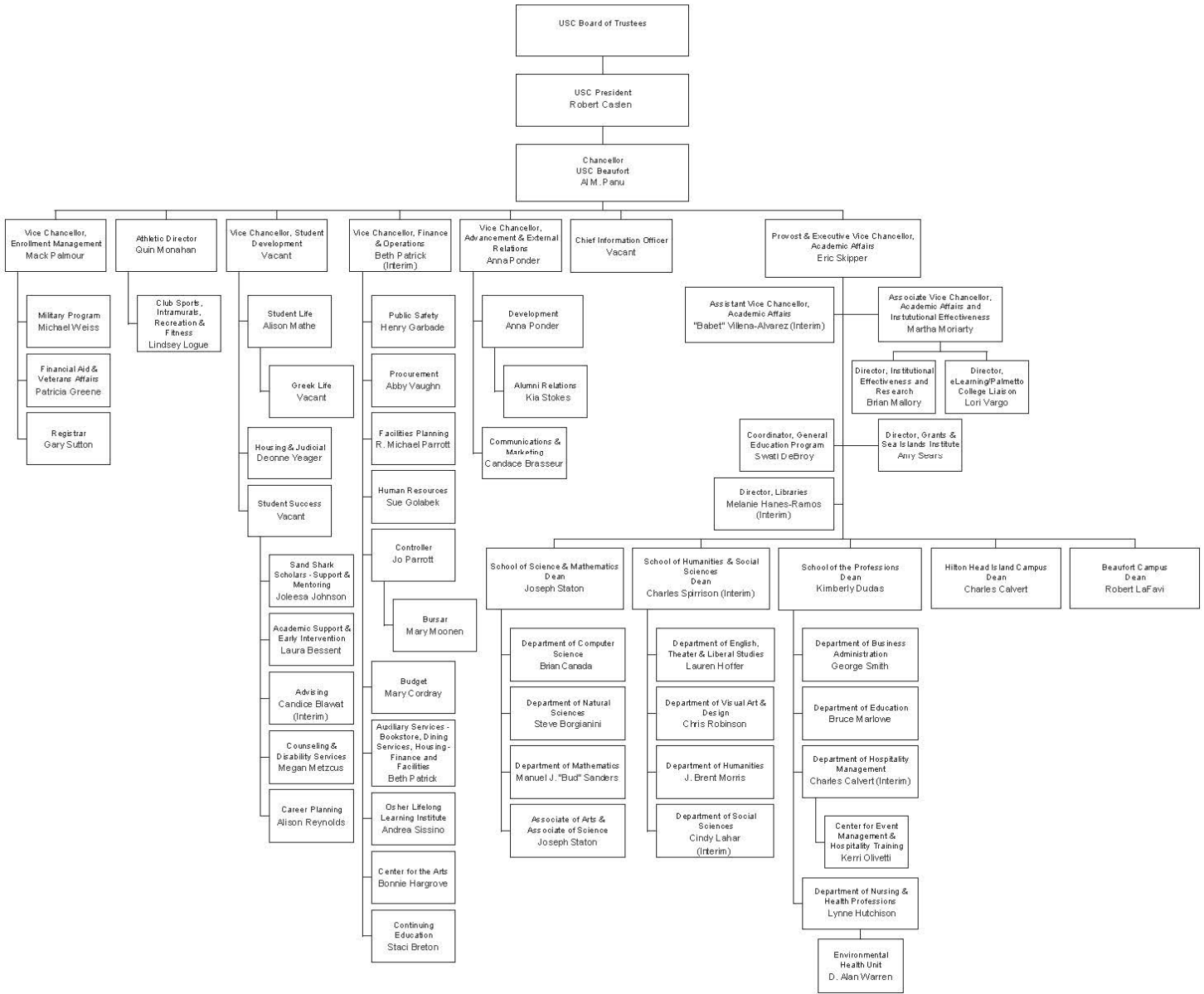
